**IMPORTANT:**

1. Those registered for AIOTA membership Examination IV will be provided with Enrolment Number. After passing the examination the Provisional Membership of AIOTA will be provided after payment of requisite fees as per laid down AIOTA rules for passed out graduates from the specified programs.
2. Provisional Membership of AIOTA will be issued to successful candidates after payment of the requisite fee, for the purpose of employment and/or practice in India only. They will be entitled to participate and contribute in AIOTA Conferences.
3. The Provisional Members will not have any right for voting in AIOTA Election.
4. This may be noted by the examinees that applicants who pass AIOTA examination III will not be entitled for life membership of AIOTA& WFOT accreditation.
5. The AIOTA Provisional Membership should not be considered at par with Regular Membership of AIOTA issued to Occupational Therapists graduated from AIOTA/WFOT accredited institutions, in respect to overseas education/ placements etc.
6. All applicants should submit application form individually to Dean ACOT for appearing in the Examination.
7. ACOT/AIOTA reserves the right to accept/not accept any application on whatsoever reasons and decision in this regard shall be binding.
8. Examination Fee is non-transferable and non-refundable.
