## **SUBSCRIPTION & AIOTA'S PROVISIONAL LIFE MEMBERSHIP POLICIES**

*The following information's & regulations has been updated on 1<sup>st</sup> April, 2017  
(TO BE RETAINED BY THE MEMBER)*

### 1. THE MEMBERSHIP FEES:

- a) Rs. 8000/- + Application Charge Rs. 500/- = Total Rs.8500/-
- b) Urgent Fee: Rs.12000/-plus application charges Rs.500/- (*Membership shall be given within 15 workingdays*)
- c) **Renewal of Membership Fee : Rs. 5000/- [ + Late Fee Rs. 500/- if not renewed withintime]**  
**Provisional Life Membership should be renewed after completion of 15 years of the issuance of Membership).**

2. Membership fees will be accepted by Demand Draft only, drawn at any Nationalized Bank, drawn in favour of ALL INDIA OCCUPATIONAL THERAPISTS' ASSOCIATION payable in MUMBAI. (Online submission of membership fee may also be accepted with prior information/approval from Hon.Treasurer/WebAdministrator)
3. Any future changes in address or contact nos., names should be intimated immediately to the AIOTA Web Administrator for necessary corrections on the AIOTA Mailinglist.
4. Non- receipt of AIOTA Communication should be brought to the notice of AIOTA WebAdministrator.
5. On becoming the Life Member, the member shall receive one Membership Certificate, ACOT Registration Certificate, Membership Card and an AIOTABadge.
6. The photocopy of the form will not be accepted; only original print on A-4 size Executive Bond paper will beaccepted.
7. The applicant should sign across the affixedphoto.

8. The ProvisionalLife Members will be entitled to access the AIOTA Membership Directory on [www.aiota.org](http://www.aiota.org)and one page will be dedicated to the member with his/her contactinformation.
9. The Provisional Life Membership will be valid for a specified duration and will not hold good after the specified term. Currently it is 15 years of uninterrupted life membership effective from the date of issuance ofMembership.

11. The Provisional Membership Application Form without duly signed Undertaking will not beaccepted.
12. Membership except the Urgent Provisional Membership is approved during the AIOTA ECMeeting.
13. AIOTA Executive Committee is empowered to make necessary amendments/changes/ relaxations on any one of the above specified regulations as and when required
14. **The Certificate of Good Standing and/or Licensure Verification will not be issued to the Provisional Life members for overseas placements in accordance with WFOT policy.**
15. Provisional Members will not be entitled to participate in AIOTA election process including voting.
16. On becoming the Provisional Life Member, the member will be entitled to registration fees as of regular Life Members to participate in Annual National OT Conferences or COTE workshop organized by AIOTA.
17. Provisional Members will be allowed to participate in AIOTA Conference and academically contribute as AIOTA Life Members under non-competitive category of Presentations. Provisional members will be entitled to participate and /or contribute in AIOTA/ACOT organised Continued OT Education Programs.
